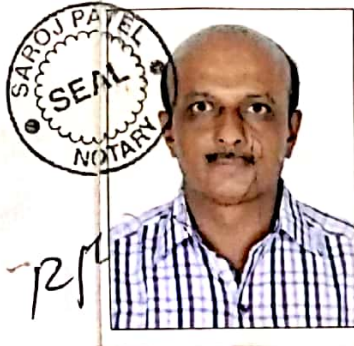
3 That the land is lease from Shri Chamunda Education Trust for a minimum period of 51 years (in figures 51 years and words Fifty One Years)
